## CFD on Equities (Shares)

### Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

CFDs are manufactured and provided by Number One Brokers Ltd ("NOB", "we"), a limited liability company incorporated under the laws of the Republic of Mauritius. NOB is authorised to provide investment services by the Financial Services Commission, Mauritius (FSC) and holds an Investment Dealer (Full Service Dealer, excluding Underwriting) licence, Licence No. GB20025378 (licence category SEC-2.1B). **You are about to purchase a product that is not simple and may be difficult to understand.**

### What is this product?

**Type:** A CFD on equities is a leveraged contract entered into with NOB on a bilateral, over-the-counter basis. It allows an investor to speculate on rising or falling prices of an underlying exchange-listed share, without buying or selling the share itself and without acquiring shareholder rights such as voting rights. An investor may buy ('go long') the CFD to benefit from a rising share price, or sell ('go short') to benefit from a falling share price. At close-out, one party pays the other the difference between the closing value and the opening value of the contract. The price of the CFD is derived from the price of the underlying share on its primary listing venue. Positions are adjusted for corporate actions of the underlying issuer (for example dividends, splits and rights issues). The leverage embedded in the CFD magnifies both profits and losses.

**Objectives:** The objective of the CFD is to allow an investor to gain leveraged exposure to the movement in the value of the underlying listed share (whether up or down), without buying or selling the underlying instrument. The exposure is leveraged because the CFD only requires a small proportion of the notional value of the contract to be put down as initial margin. As a matter of policy, NOB applies to retail clients leverage limits, a margin close-out rule and negative balance protection consistent with the ESMA product intervention measures applicable to CFDs in the European Union. For this product class the initial margin requirement for retail clients is 20% of the notional value of the position (maximum leverage 5:1).

As an example, if an investor buys a CFD on NVDA (NVIDIA Corp., NASDAQ, ISIN US67066G1040) covering 100 shares at a price of USD 180.00 (rounded market price level as at 1 March 2026, used for illustration), the notional value of the position is USD 18,000.00 and the initial margin required is USD 3,600.00. For each 1% change in the price of the underlying, the value of the position changes by USD 180.00, i.e. 5.0% of the initial margin. Additional funds may need to be deposited if the price moves against the position; failure to maintain the required margin may result in the position being closed automatically.

The CFD has no fixed maturity date and no recommended holding period; it is generally used for intraday or short-term trading. The position remains open until you close it, or until it is closed by NOB in accordance with the margin close-out rule or the Terms of Business. It is at the discretion of each investor to determine the appropriate holding period based on their individual trading strategy and objectives.

**Intended retail investor:** CFDs are intended for investors who have knowledge of, or experience with, leveraged products; who

understand how CFD prices are derived, the key concepts of margin and leverage, and the risk/reward profile of the product compared with traditional dealing in the underlying listed share; who have appropriate financial means and the ability to bear a loss of the entire amount invested; and who pursue short-term, typically speculative, trading objectives.

## What are the risks and what could I get in return?

The risk indicator assumes that you may not be able to buy or sell your CFD at the price you wanted to due to volatility of the market, or you may have to buy or sell your CFD at a price that significantly impacts how much you get back.

We have classified this product as 7 out of 7, which is the highest risk class. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. CFDs are leveraged products that, due to underlying market movement, can generate losses rapidly. It is possible to lose the entire amount invested in a given position, and you may be required to deposit additional funds to maintain your positions.

Negative balance protection applies to retail client accounts: your aggregate losses are limited to the total funds on your trading account, and you cannot lose more than this amount. If the total margin posted on your account falls to 50% of the minimum required margin for your open CFD positions, NOB is required to close one or more of those positions. Market conditions may mean that positions are closed at a less favourable price, which could significantly impact how much you get back. There is no capital protection against market risk, credit risk or liquidity risk.

Be aware of currency risk: where you trade a CFD denominated in a currency other than the base currency of your account, your final return also depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. Individual shares can be subject to issuer-specific events (earnings releases, profit warnings, takeovers, suspensions) that cause sharp price gaps, including outside the trading hours of the relevant exchange, when positions cannot be closed. Short positions are additionally exposed to borrow recalls and increased borrow costs.

## Performance scenarios

The scenarios shown illustrate how your investment could perform; they are not an exact indicator and are not based on a guaranteed outcome. What you get will vary depending on how the market performs and how long you hold the CFD. The stress scenario shows what you might get back in extreme market circumstances and does not take into account the situation where we are not able to pay you. The following assumptions have been used (position assumed to be opened and closed within the same day; figures are net of opening and closing commissions, before any rollover fees and currency conversion):

### What happens if Number One Brokers Ltd is unable to pay out?

If NOB is unable to meet its financial obligations to you, you could lose the entire value of your investment. ### What are the costs?

Trading this CFD incurs the following costs. Commissions and rollover rates differ from instrument to instrument and may change over time: you must always consult your Client's Area for the commission and rollover rate applicable to the specific instrument before trading. ### How long should I hold it and can I take money out early?

CFDs are intended for short-term trading, in many cases intraday, and are generally not suitable for long-term investment. There is no recommended holding period, no cancellation period and no cancellation fee. You can open and close a CFD on a listed share at any time during the trading hours of the relevant market. Holding a position overnight incurs rollover fees, which over longer periods can materially erode returns.

### How can I complain?

If you wish to make a complaint, you should first address it to the local distributor with which you have a trading agreement, in accordance with that distributor's complaints procedure.
